- Give back to the PPG communities through COLORFUL COMMUNITIES® projects around the world

We have a commitment to sustainability as a core value with our suppliers. Our <u>Global Code of Ethics</u>, <u>Supplier Sustainability</u> Policy and <u>Global Supplier Code of Conduct</u> clearly state our expectations for every supplier.
