To this end, we attribute great importance to respect for human rights and environmental protection – in our own business area and along our supply chains. Specifically, this means:

- Consistent adherence to country-specific regulations, prohibitions and directives.
- Fairness, education and a minimal impact on the environment: we are committed to this

- Diversity, equal opportunities and respectful dealings with employees and partners are key cornerstones of our success. We also support social projects.
- As a subsidiary of International Distributions Services plc, we are a signatory of the United Nations Global Compact. The principles contained in this internationally applicable set of rules on human and labour rights, environmental standards and combating corruption form the basis for our Code of Conduct and Supplier Code of Conduct.

New laws, such as the German Act on Corporate Due Diligence Obligations for the Prevention of Human Rights Violations in Supply Chains (LkSG), no longer relate sustainability considerations to individual companies alone but to entire supply chains. People and the environment in which we all live are the focus of our shared responsibility. We take this responsibility towards employees, society and the environment very seriously. It forms the basis for the trust placed in GLS Germany by employees, customers, business partners and the public.

Contribute to sustainability as a supplier

GLS Germany and its affiliated companies are committed to environmentally and socially responsible corporate governance. We demand the same of our suppliers. With regard to our employees, too, we require that they observe the principles of ecological, social and ethical behaviour and consider them part of our corporate culture.



As a supplier to GLS Germany, you also play your part in an integrated approach and contribute to optimising corporate action and services in the interests of sustainability. Only if we work together we can effect a lasting improvement in environmental protection and respect for human rights.

It matters to us that our partnership with you is based on trust. In order to achieve our mutual objectives while meeting all legal requirements, the first step is a risk analysis that incorporates various information about your company. Responsible action along the supply chain is a must at every point in our business relationship. That is why all human rights and environment-related risks have to be promptly identified and reported as well as appropriate steps taken to minimise the risk.

We set out below how you can play your part in this and benefit at the same time.

The onboarding process for new suppliers includes a supplier questionnaire and information on our Supplier Code of Conduct. Purchases are double-checked or, in the case of larger orders, have to pass a business partner approval procedure. A business relationship can only be established and a potential business partner added to our central procurement platform if the supplier meets our values and legal requirements.

EcoVadis is a leading international CSR* rating platform. The cooperation is intended to help us to further improve our services in respect of sustainability and to put our sustainability management in the supply chain on a future footing. You are invited to participate in this in order to play your part in an integrated approach.

Slowly but surely, we want to bring more transparency to our supply chains through this so that we can prevent risks arising or take timely steps to counteract them together with our business partners. The extension of our risk management system to include measures for implementing the LkSG will ensure increased awareness both in our own business area and along our supply chains.
