Through EcoVadis, we will work with you to improve our collective Environmental, Social, and Governance (ESG) and Sustainability performance. We will do this by:

- Monitoring your organisation's ESG performance, including alignment with our Supplier Code of Conduct.
- Co-developing action plans to maintain or improve ratings year-on-year.
- Working together to realise our ESG goals. Championing and rewarding third parties who demonstrate ESG excellence.

The EcoVadis assessment
